Description

Standard Chartered Tax Facility cashback has concrete mechanics to follow before the deadline. Standard Chartered Beyond and Visa Infinite cardholders can receive 100% cashback on the 1.90% income tax facility processing fee, capped at S\$200.

How To Use It

1. Submit the Tax Facility application during the promotion period.
2. Upload the latest IRAS Notice of Assessment.
3. Ensure the application reaches the bank at least 14 business days before the tax payable due date under the cashback terms.
4. Keep enough credit limit for the approved tax amount and 1.90% processing fee.
5. Use the credited funds to pay IRAS directly after approval.

Spend, Caps And Exclusions

- Facility is not available to Standard Chartered Priority Banking Visa Infinite Credit Card cardholders.
- Designated account must be a Standard Chartered current or savings account.
- Processing fee of 1.90% of approved tax payable amount is charged to the eligible card.
- Card and bank accounts must remain valid, in good standing and satisfactory when cashback is credited.
- Cashback equals 100% of processing fee, capped at S\$200 per eligible cardholder.
- Only the first 25 approved applications per calendar month during the promotion period qualify.
- Only income tax payments based on IRAS NOA are covered by the facility.
- Promotion is not valid with other offers, discounts, rebates, privileges or promotions unless stated.
- Cashback is not transferable or exchangeable for cash or other items.
- No compensation is made for lost, misplaced or stolen cashback.

When The Reward Arrives

- Approved amount is charged to the eligible card and credited to the designated account.
- Cashback for qualified cardholders is credited to the eligible card account by 31 August 2026.
- Miles are credited in the form of Rewards Points based on the relevant card earn rate.
