



Yardbird Singapore for Groups: Cost the Table First

Description

Yardbird at Marina Bay Sands works best for a group when the organiser decides format first: restaurant table or pre-ordered takeaway. The official ordering page lists large boxes, but availability can close; a displayed price is not proof that the chosen date can still be ordered.

Yardbird Singapore group dining: the decision table

Situation	What to do
Six to eight people want full service	Reserve a table and share dishes
Large casual gathering elsewhere	Compare official takeaway boxes
Dietary restrictions matter	Check ingredients directly before ordering
Collection page shows closed	Do not promise that menu to the group

This is a planning guide, not a review

We have not eaten the current menu and make no first-hand claim about taste, service or portion adequacy.

Price the complete table

Add food, drinks, service charge and GST where applicable. For takeaway, add transport, serving ware and food-holding time.

Portion claims need a buffer

A box's item count does not establish how many adults it will satisfy. Ask the restaurant and build extra sides for appetite and dietary differences.

Choose signature versus variety

A chicken-focused group may prioritise the core dish; a mixed group needs vegetables, non-chicken mains and clear allergy checks.

Lock collection logistics

Confirm date, time, collection point, name, phone and reheating or holding instructions before collecting a large order.

Worked example

If a S\$174.40 box is shared among eight people, the base division is S\$21.80 each before additional dishes, drinks, transport or taxes not already included. At six people it is about S\$29.07. These are simple divisions of a displayed price, not a claim about serving size or availability.

Turn the example into a decision record

The worked example is useful only if its inputs are replaced with the reader's actual dates, amounts, documents or observations. For this task—choose dine-in or takeaway and set a transparent per-person budget—keep the decision and its supporting record on the same line. That exposes a missing input before the action becomes difficult to reverse.

Trigger or question	Current action	Evidence to retain
1. Six to eight people want full service	Reserve a table and share dishes	Save the dated input, confirmation or advice that supports this choice.
2. Large casual gathering elsewhere	Compare official takeaway boxes	Save the dated input, confirmation or advice that supports this choice.
3. Dietary restrictions matter	Check ingredients directly before ordering	Save the dated input, confirmation or advice that supports this choice.
4. Collection page shows closed	Do not promise that menu to the group	Save the dated input, confirmation or advice that supports this choice.

Record where each answer came from and when it was checked. If a live service, signed document or professional opinion conflicts with a general webpage, preserve both and resolve the difference with the body responsible for the decision. Do not silently substitute a convenient number or date.

Action checklist

1. Choose dine-in or takeaway
2. Confirm current menu and hours
3. Count dietary requirements
4. Estimate portions conservatively

5. Add all-in costs
6. Book or order through the official page
7. Reconfirm on the day

Two practical tools to keep

A six-versus-eight-person cost table. Put the controlling dates, amounts or observations in one place and attach the evidence beside each input. This makes the decision reproducible if a family member, colleague or adviser needs to check it later.

A dine-in-versus-takeaway logistics checklist. Test the ordinary case and the failure case before money, a filing or a booking becomes irreversible. Mark calculations as calculations and leave uncertain fields unresolved until an authority or qualified professional confirms them.

What the primary sources establish

Primary source	Claim used here
Yardbird Singapore official page	Location, meal periods, menu and reservation information.
Yardbird official takeaway ordering	Current box contents, listed prices and collection availability.

The links sit beside the claims they support. Live services, formal notices and individual facts can change the outcome, so re-open the controlling page immediately before acting.

Continue with the next useful step

For the adjacent task, read [the booking conditions at 1887 by Andr  ](#). If the decision moves into a different stage, continue with [a casual Tampines noodle option](#).

Errors that change the outcome

- Calling this a first-hand review
- Dividing price without checking portions
- Forgetting service charge and GST
- Assuming a displayed box is available
- Ignoring collection travel time

Keep dated records, confirmations and advice used for the decision. This article explains public information for a general fact pattern; it does not determine an individual legal, tax, medical, investment, employment or contractual outcome.

A final challenge before acting

The intended reader is a singapore organiser planning a casual group meal at marina bay sands. Before closing the task, challenge the file against the common failure points below. A â??not

applicable?• answer should still have a reason, especially where a deadline, eligibility rule, payment, booking or safety decision is involved.

- **Have you ruled this out?** Calling this a first-hand review. Write down the fact or document that answers it; an assumption is not a completed check.
- **Have you ruled this out?** Dividing price without checking portions. Write down the fact or document that answers it; an assumption is not a completed check.
- **Have you ruled this out?** Forgetting service charge and GST. Write down the fact or document that answers it; an assumption is not a completed check.
- **Have you ruled this out?** Assuming a displayed box is available. Write down the fact or document that answers it; an assumption is not a completed check.
- **Have you ruled this out?** Ignoring collection travel time. Write down the fact or document that answers it; an assumption is not a completed check.

Escalate any unresolved consequential point to the named authority or an appropriately qualified professional. The aim is not to collect more material; it is to identify the one missing fact that could change the result.

Where is Yardbird Singapore?

At The Shoppes at Marina Bay Sands; check the official page for the current unit and hours.

Can large takeaway boxes be ordered any day?

Availability is controlled by the live ordering page and may close.

Is the per-person calculation a serving promise?

No. It is a budget division only.
